

BOARD MEETING

DATE: 8/24 1982 AGREEMENT

ACTION: 4

This agreement entered into this 17th day of August 1982,

by and between the County of Nassau, by and through the Board of County Commissioners of Nassau County and the Town of Callahan, by and through the Town Council of Callahan, who for and in consideration of the amounts of monies and services hereinbelow expressed agree as follows:

1. Nassau County agrees to construct and pave certain streets in the Town of Callahan known as Third Avenue from U S #1 to Booth Street and Booth Street to Mickler Street.
2. The total cost of said road shall not exceed TWELVE THOUSAND, FIVE HUNDRED DOLLARS (\$12,500.00) unless approved by the Callahan Town Council.
3. The road to be constructed by the County shall be eighteen feet in width, with a limerock base, finished and primed. The asphalt Type II to be installed by others under contract, and not a part of this agreement.
4. Upon certification by the County Engineer that the road is completed and upon submission of an invoice, the Town of Callahan shall forward the full payment of said invoice to the County of Nassau within five days of the receipt of same.
5. The Town of Callahan agrees to indemnify the County of Nassau for any liability for any damages of any kind, whatsoever, attributable to said County during construction of said road unless such damages be caused by the negligent acts of the County of Nassau or its employees or agents.

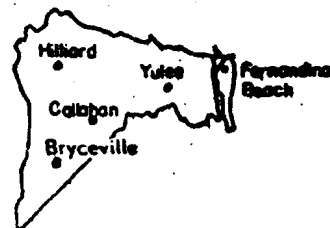

I was requested by Mr. Leon Hodges to propose estimates for the construction of two (2) City streets in the Town of Callahan.

PROJECT # 1. 3rd St. (Booth St. to US #1)

Approximate cost of construction-----\$6,000.00
Type 2 surfacing--additional----- 2,500.00
(approximately 72 Tons @ estimated cost of \$35.00 per Ton)

PROJECT # 2. 3rd St. (Booth St. to Mickler St.)

Approximate cost of construction-----\$6,500.00
Type 2 surfacing--additional----- 3,000.00
(approximately 85 Tons @ estimated cost of \$35.00 per Ton)

As I stated to Mr. Hodges, this would have to be approved by the Board of County Commissioners. Also I advised that our schedule is quiet full at this time and I am not sure if and when the construction could be completed.
