THIS AGREEMENT, made and executed in duplicate this

East Bay Street, Jacksonville, Florida, 32202, party of the first part, and NASSAU COUNTY, a Political Subdivision of the State of Florida, party of the second part.

WHEREAS, under date of October 1 , 1973, the party of the first part submitted to the party of the second part a written planning proposal for Nassau County, dated August, 1973, to continue work on the county's Land Use Plan for and in consideration of the sum of \$5,000.00, to be completed by November 30, 1973, and in consideration of the sum of \$10,000.00 for development of zoning ordinance, text and atlas, to be completed by February 28, 1974, and said cost prices being estimates and not to exceed the amounts above set forth, and to be paid in installments from time to time, and it is mutually agreed that all maps, atlas, and other material to be furnished the county are to be included in the overall cost, including 100 copies of the preliminary land use study, and 100 copies of the proposed zoning ordinance, plus one reproducible copy of the zoning atlas, and

NOW, THEREFORE, in consideration of the foregoing and in further consideration of the proposal of the first party, as outlined in the planning proposal for Nassau County, dated <u>October 1</u>, 1973, a copy of which is hereto attached as "Exhibit A", and by reference made a part hereof, and in further consideration, without additional charge, of the instruments above set fourth, second

party agrees to accept such proposal and first party agrees to perform the services as outlined therein.
