 LUCILLE P. HARGER requests and hereby gives permission to the COUNTY of Nassau to enter upon her property as follows:

The COUNTY may enter and remove sand from a strip, 45 feet wide of the western perimeter of lots 1 and 2 from a height of 15 feet to a reduced height of 3 feet, thus lowering the perimeter 12 feet and in addition, the COUNTY may enter and remove sand from a strip 45 feet wide of the northern perimeter of lot 1 from an estimated height of 15 feet to a reduced height of 3 feet. The attached drawing agreed to by both parties is attached and shall be referred to in case of dispute.

2. The COUNTY agrees to enter and remove the sand as described in paragraph 1 on or before December 31, 1983.


