

AGREEMENT

THIS AGREEMENT made and entered into this 25 day of October, 1983, by and between the County of Nassau, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and the West Nassau County Chamber of Commerce, hereafter referred to as CHAMBER.

W I T N E S S E T H

WHEREAS, it is in the best interests of the citizens of Nassau County to have a Chamber of Commerce to promote the interests of West Nassau County and all of Nassau County, and

WHEREAS, the CHAMBER has agreed to devote its efforts to the betterment of all the citizens of Nassau County;

NOW, THEREFORE, the parties hereto agree as follows:

1) For and in consideration of the sum of \$2,000.00, which shall be paid in quarterly installments to the Chamber of Commerce, the CHAMBER does hereby agree to perform services that will benefit all the residents of Nassau County. Said services to include but not limited to the following:

- (a) Promotion of West Nassau and Nassau County.
- (b) Encourage business entities to settle in Nassau County.

2) THE CHAMBER shall make their financial records available to the COUNTY for purposes of an audit, if requested, by the COUNTY.

IN WITNESS WHEREOF, the parties hereto have duly executed this Agreement this 8<sup>th</sup> day of November, 1983.
