AGREEMENT

NOW THEREFORE, the Parties hereto agree as follows:

1.) Pat Waiddon hereby agrees to permit Nassau County to enter WHITEN her property and bury said tires.

4.) Pat Wintdom² hereby agrees to repay the County of Nassau WAITENup to an amount of \$500.00 as reimbursement for said County work.
