A G R E E M E N T

THIS AGREEMENT entered into this 11th day of December 1984, by and between Thomas D. Branan of 84 Pirates Point Road, Yulee, Florida, herein referred to as "BRANAN" and Nassau County, a governmental subdivision of the State of Florida, hereinafter referred to as "COUNTY", who for and in consideration of the compensations, services, goods and valuable considerations agree as follows:

1. BRANAN shall serve as in-service training instructor for Nassau County's Department of Emergency Services and shall be responsible for the following:

A. Shall provide no less than 36 hours of in-service training for Nassau County Rescue Division Personnel.

B. Shall submit to the Director of Emergency Services no later than the 5th of the month a lesson plan, schedule of classes, and materials needed.

C. All lesson plans shall be approved by Nassau County's Medical Director.

D. Shall provide records of all training received by personnel indicating a pass/fail result.

E. 50% of all training shall be devoted to CEU's for recertification.

F. Classes shall be offered at three locations on all three shifts for a total of nine classes per month.

2. BRANAN shall be compensated at the rate of FIVE HUNDRED DOLLARS (\$500.00) per month for the period of one year.

3. This agreement may be canceled by written notice by one party to another at their normal mailing address notifying said party of termination at the end of thirty (30) days from receipt of said notice.

4. This agreement may be amended by mutual written agreement signed by both parties hereto.
