Dear Messrs. Blackwelder and Albert:

This letter represents the formal modification to the Local Government Comprehensive Planning Assistance Program contract (No. 87-LP-03-04-55-01-281, effective March 1, 1987).

Section XII on page 4 of the contract provides for amendments through mutual agreement and written correspondence from the Department. Nassau County and Fernandina Beach, in a letter dated August 20, 1987, requested an extension to the contract pursuant to Rule 9J-16.005(7), Florida Administrative Code.

Based upon the letter, the following modifications are made to Attachment A, Scope of Services/Schedule of Deliverables. Item 2 in Section (a) Scope of Services/Schedule of Deliverables is amended to read as follows:

- (2) (a) The identification of issues unique to Amelia Island which would benefit from improved or additional intergovernmental coordination.
- (b) With these issues identified, develop a series of intent statements to be used as the basis for the

- (b) With these issues identified, develop a series of intent statements to be used as the basis for the development of the Comprehensive Plan for Amelia Island. These intent statements will be used as the basis for the goals and objectives and policies of the individual plan elements. These statements are intended to establish the character of Amelia Island and be sensitive to the unique natural resources of the island.

Based upon the County's request, the following modification is made to Section XI(B) of the contract:

(B) All activities performed pursuant to this program shall be completed on or before November 30, 1987 which includes an extension pursuant to Rule 9J-16.005(7), Florida Administrative Code.

All other provisions of the contract are still in effect and are to be performed as specified in the contract. This modification is effective on September 8, 1987 and is hereby made


