This will be an agreement between you and Florida Public Utilities Company relative to a water service and a tap for a 6" fire line at the following location: Nassau County Courthouse on South 5th Street and Centre Street, Fernandina Beach, Florida.

Characteristics of this facility will be as follows:


Size	<u>6"</u>
Type of Material	<u>C. I.</u>
Length	<u>20'</u>

We estimate the flow from this service and tap to be approximately 500 gallons per minute. The estimated cost of installing this 6" fire line to be \$1,490.00, of which Florida Public Utilities Company is to bear none of this cost. It will be your responsibility to provide and install a double check valve on the 6" fire line.

Quotations of cost of facilities to be extended in this agreement are firm for sixty (60) days from the date of this agreement.

Upon receipt of \$1,490.00 and acceptance by you of this agreement, we shall commence construction as soon as materials and labor can be made available.

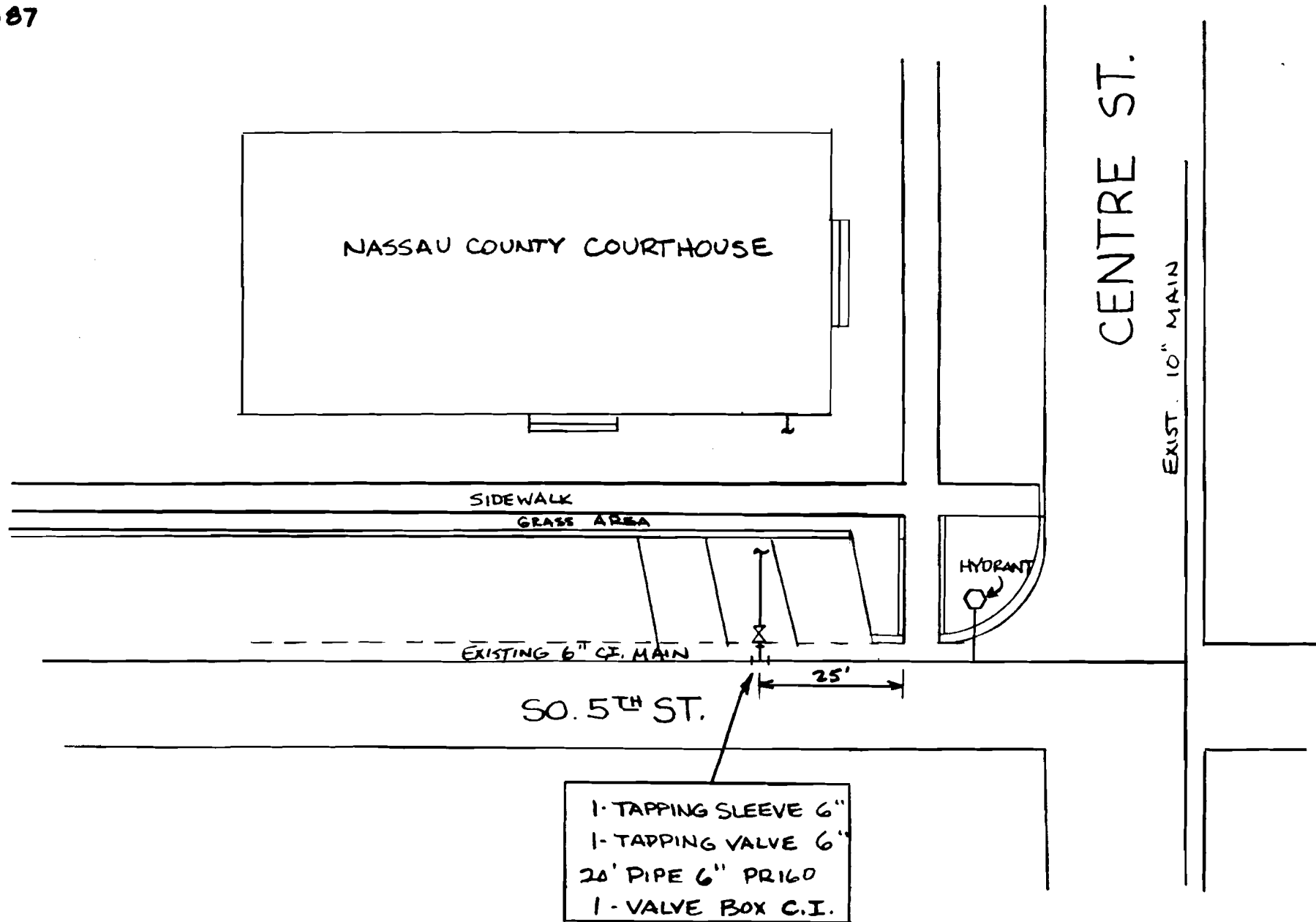
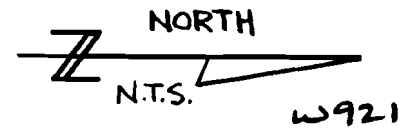
