AGREEMENT

THIS AGREEMENT entered into this 22nd day of March, 1988, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, (hereinafter referred to as "County"), and NASSAU SANITATION SERVICE, INC., (hereinafter referred to as "NSS"), whose address is Post Office Box 648, Fernandina Beach, Florida, 32034.

For and in consideration of ten and no/100 dollars (\$10.00) and other valuable considerations, the parties agree as follows:

- 1. NSS shall provide twenty (20) cubic yard refuse containers to County pursuant to the specifications attached hereto and made a part hereof as Exhibit "A".
- 2. The parties further agree that this Agreement may be terminated by the County with thirty (30) days written notice to NSS. If the Agreement is terminated, the amount owed for that month shall be pro-rated, and the County shall not be liable for any remaining payments to NSS.
- 3. This Agreement shall be for a period of one (1) year and may be renewed for one (1) year at the option of County.
- 4. County shall pay NSS the amount of five thousand seven hundred sixty-one dollars and fifty cents (\$5,761.50) per month during the term of the Agreement.

EXHIBIT "A"

SPECIFICATIONS

The contractor will place two, twenty yard or larger containers at the former Lofton Creek Landfill site, and one, twenty yard container or larger at the former Bryceville Landfill site. Specific sites to be designated by the Nassau County Engineer.

The containers must be of a size or configuration to allow the dumping of household trash bags in a convenient fashion. It is intended to allow only household bagged or boxed trash to be placed in these receptacles. The county will man these stations to verify trash collected.

The contractor will be responsible for pickup of the containers and hauling to the West Nassau Landfill. Necessary covering of the containers will be required while in transit. The contractor will schedule pick-up and delivery of the containers to allow the follow number of pick-ups:

Lofton Creek 2 per day - 6 days a week

Bryceville 2 per week

Award will be based on the total cost of rental and delivery charges. The county may require additional pick-ups depending on quantities of trash received but the delivery cost will be at the bid rate. The contract will be for a one year period with renewal for an additional year for the rate listed under year two if at the option of Nassau County.

Bryceville to Callahan.

Hauling Charges:

\$90. per pull from Lofton Creek to Callahan.

\$112.50 per pull from Bryceville to Callahan.

(based upon \$90. per hour)

Rental Charges:

\$50. per month per container.

For Example:

Two pulls per week @ Bryceville = \$ 225.00 Twelve pulls per week @ Lofton Creek 1080.00

weekly total 1305.00 weeks in months x 4.3

total monthly hauling \$ 5611.50 rental charges + 150.00

monthly total \$ 5761.50

The above figures are based upon a signed Service Agreement and a stipulation that there will be no landfill charges applied to dump these containers at the Callahan landfill.
