

MEMORANDUM OF UNDERSTANDING BY AND BETWEEN THE
FLORIDA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES
AND THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY

1. The Board of County Commissioners of Nassau County agrees to the installation of a central air conditioning system in the Nassau County Agriculture Multi-Purpose Building as envisioned in Chapter 90-209, Laws of Florida, Section 2G, Item Number 2222A.
2. The Board of County Commissioners of Nassau County agrees that selection of the contractor will be in accordance with approved selection processes.
3. The Board of County Commissioners of Nassau County agrees that the project is subject to state audit.
4. The Florida Department of Agriculture and Consumer Services agrees to remit to the Board of County Commissioners of Nassau County up to \$50,000 as provided in Chapter 90-209, Laws of Florida, Section 2G, Item Number 2222A. The Department may advance the expected cash needs within the initial three month period of this agreement, as noted in Section 216.181(12), Florida Statutes. Thereafter, disbursements shall be made on a reimbursement basis. These funds shall be deposited in a separate account and may be invested. All investment earnings shall be returned to the Department of Agriculture and Consumer Services. Requests for reimbursement shall be supported by copies of paid invoices or other acceptable documentation.
5. This Memorandum of Understanding is subject to the provisions of Chapter 287.058, Florida Statutes.
6. This Memorandum of Understanding is subject to the availability of funds as provided by the Legislature, the release of such funds as approved by the Governor's Office of Planning and Budgeting and the approval of the State Comptroller (Department of Banking and Finance.)
7. All property constructed or purchased with these funds is the property of the Florida Department of Agriculture and Consumer Services.


