AGREEMENT

THIS AGREEMENT entered into this 13^{th} day of May_{1} , 1991, by and between the ECARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, and <u>Paige Alvarez</u>.

WHEREAS, the Board of County Commissioners has received a Recycling Education Grant; and

WHEREAS, the Cooperative Extension Service is the most appropriate County office to provide the administration of the education program.

NOW, THEREFORE, FOR and IN CONSIDERATION of ten and no/100 dollars(\$10.00), the parties agree as follows:

1. <u>Paige Alvarez</u> shall perform the duties of an extension program aide under the direction and supervision of Mary Williams, the Nassau County Extension Services Director.

2. <u>Paige Alvarez</u> shall work a total of not more than four hundred(400) hours during the term of this Agreement. Said Hours shall be pursuant to a work schedule as determined by Mary Williams.

3. <u>Paige Alvarez</u> shall be compensated at the rate of \$10.80 per hour during the term of this contract.

4. <u>Paige Alvarez</u> shall be entitled to receive up to four hundred(\$400.00) dollars during the term of this Agreement as and for any travel expenses.

5. <u>Paige Alvarez</u> shall be responsible, pursuant to the direction of Mary Williams, for coordinating the education programs for solid waste management and recycling.

6. Mary Williams shall keep an account of <u>Paige Alvarez</u> hours and work programs and shall establish with the Clerk's Office a method of payment to <u>Paige Alvarez</u> and the appropriate documents to be maintained indicating work performed, hours worked, and the documents for travel reimbursement.

7. The term of this Agreement shall terminate no later than September 31, 1991.


8. This Agreement may be terminated by the Board of County Commissioners by providing <u>Paige Alvarez</u> with thirty (30) days written notice.
