1. SERVICE:

- a. Service will be performed for the control of roaches, ants, rats, silverfish, fleas, spiders, and mice at the locations listed on Attachment A.
- b. In the event of persistent infestations special service will be provided, at no extra cost, until the condition is under control.
- c. Special service calls shall be handled within 24 hours.
- d. All service, regular and special, will be performed at the convenience of the Nassau County so as not to interrupt our normal operations.
- e. All service shall be under the direction and supervision of a Florida State Certified Pest Control Operator.
- f. All Buildings listed on Attachment A will be treated annually for termites.

2. MATERIAL:

- a. The materials used in pest control work shall conform to federal, state and local ordinances and laws.
- b. Rodenticides shall be used with all due precaution to avoid accidents to humans, domestic animals and pets.
- c. All pest control work shall be performed in a safe manner and in accordance with the most modern and effective scientific pest control procedures.

3. TERMS OF AGREEMENT:

- a. This agreement shall be effective for a period of one year, beginning October 1, 1992 and ending September 30, 1993.
