- 1. The Department shall provide fire protection for <u>335,399</u> acres of forest and wild lands within <u>Nassau</u> County.
- 2. The County shall, under the terms of this agreement, pay to the Department annually as its share of the cost of providing such fire protection \$10,061.97, aid receipts to be deposited in the General Revenue Fund of the State.
