THIS AGREEMENT, made and entered into this 3rd day of June, 1993, by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, hereinafter called the DEPARTMENT, AND CSX Transportation, Inc. a corporation organized and existing under the laws of Florida, with its principal place of business in the City of Jacksonville, County of Duval, State of Florida, hereinafter called the COMPANY, and the County of Nassau, a political subdivision of the State of Florida, hereinafter called the COUNTY.

WITNESSETH

WHEREAS, the DEPARTMENT, the COMPANY and the COUNTY heretofore on the 25th day of August, 1975, entered into an Agreement for the installation of automatic grade crossing traffic control devices designated by the DEPARTMENT as Job No. 74590-6901, ~~DEPARTMENT~~ on CR 119 and CR 119, which crosses at grade the right of way and track(s) of the COMPANY at FDOT/AAR Crossing Number 620760-C, located near Bryceville, Florida as shown on DEPARTMENT'S Plan Sheet No. 1 attached hereto as a part hereof; and

WHEREAS, the parties hereto now mutually agree that said grade crossing traffic control devices are no longer required at said grade crossing; and



NOW, THEREFORE, in consideration of the mutual undertakings as herein set forth, the parties hereto agree as follows:
