## INTERLOCAL AGREEMENT

WHEREAS, Nassau County, pursuant to <u>Florida Statutes</u>, 212.055(3), qualifies for the small county surtax; and

WHEREAS, the Board of County Commissioners finds that it is in the best interest of the citizens of Nassau County to utilize the proceeds of a 0.5 cent sales tax for operating expenses for the Nassau County landfill; and

WHEREAS, the utilization of the sales tax will allow the reduction of the assessment and the commercial tipping fee; and

WHEREAS, the City of Hilliard is entitled, under the statutory formula, to receive  $\pm$ \$78,940.00 of the monies collected; and

WHEREAS, if each Town contributes their share towards the operational expenses of the West Nassau Landfill, the tipping fee would be further reduced to \$45.00 per ton, and the annual assessment would be further reduced to \$59.00; and

WHEREAS, the City of Hilliard would receive a proportionate share of any additional amounts received.

NOW, THEREFORE, FOR and IN CONSIDERATION of the mutually agreed upon consideration the parties agree as follows:

1. The City of Hilliard's statutory share of the 0.5 cent sales tax may, upon the condition set forth above, be given to the Board of County Commissioners to be used for the operational expenses of the West Nassau Landfill. If the sales tax from the unincorporated areas exceeds \$1,600,000.00, the City of Hilliard shall receive its proportion of the tax to the extent such figure is exceeded. (Ex. If the County receives 110% of \$1,600,000.00,

the Town of Hilliard shall receive 10% of its tax revenue).

2. If the Town of Hilliard contributes its statutory share as agreed to herein, the Board of County Commissioners agrees to reduce the tipping fee to \$45.00 per ton and the annual assessment to \$59.00.

3. This Agreement shall expire on or before December 31, 1994.
