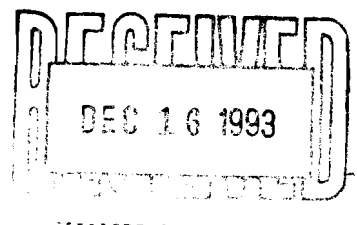


FORM OF AGREEMENT

THIS AGREEMENT, made this 1st day of December, 1993, as awarded in a Special Meeting by the Nassau County Commission on the 29th day of November, 1993, by and between the NASSAU COUNTY BOARD OF COMMISSIONERS, hereinafter called "OWNER", and HINSON ELECTRICAL CONTRACTING CO., INC., hereinafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

1. The CONTRACTOR will commence and complete the A1A/AMELIA ISLAND PARKWAY INTERSECTION TRAFFIC LIGHT REPAIR as shown in the attached Proposal and timeframe as specified within the attached Proposal.
2. The CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor, and other services necessary for the construction and completion of the PROJECT described herein excepting any equipment or material provided by the Florida Department of Transportation.
3. The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS on December 6, 1993, and will complete the same within the time limits as specified in the attached Project Schedule.
4. The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENTS and comply with the terms therein for the amounts as shown in the PROPOSAL SCHEDULE.
5. The term CONTRACT DOCUMENTS means and includes the following:
 - * Proposal
 - * Agreement
 - * Public Entities Crime Form
 - * Conflict of Interest Form
6. The CONTRACTOR shall invoice the OWNER upon completion of the project pursuant to the attached Proposal.
7. The OWNER, shall, upon review and approval of the work submitted, pay the CONTRACTOR in a timely fashion.




8. This agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.


9. The OWNER reserves the right to cancel this agreement if CONTRACTOR fails to complete the work as specified on the attached Project Schedule.





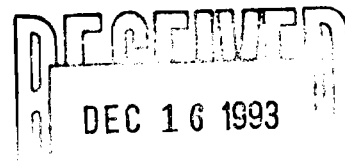

 1. A predecessor or successor of a person convicted of a public entity crime: or
 2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of a public entity crime in Florida during the preceding 36 months shall be considered an affiliate.

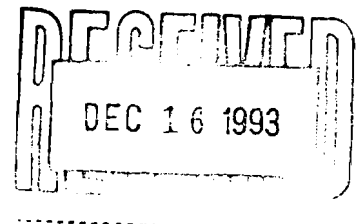
