

A G R E E M E N T

THIS AGREEMENT entered into this 9th day of January, 1995, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, hereinafter referred to as the "County", and **BERNIER, CARR, D'AMATO & ASSOCIATES**, hereinafter referred to as the "Consultant".

For and in consideration of ten and no/100 dollars (\$10.00) and other mutually agreed upon consideration, the parties agree as follows:

1. The Consultant will be available to the County's Engineering staff to conduct reviews of construction plans, permit applications, and other materials, for compliance with County ordinances and regulations, required to be reviewed pertaining to the daily operations of the Engineering staff.

2. The Consultant will make available his professional seal to certify and/or approve plans on behalf of the County, if required.

3. The Consultant will perform said services in the best interest of Nassau County as a representative of Nassau County.

4. The Consultant will perform all of the work described in this Agreement for the sum of seventy-five dollars (\$75.00) per hour.

5. The Consultant agrees to perform said services commencing January 9, 1995. This Agreement shall continue in full force and effect until written termination upon either party

and shall be reviewed on the anniversary date of this Agreement, and shall expire on that date unless extended by written agreement.

6. The County will pay to the Consultant, after verification of hourly tabulations, such amounts as are invoiced by the Consultant. Such invoice shall include the total number of hours, hourly rate, and period of the invoice.

7. This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.






