

# RELEASE

THIS RELEASE executed this 26th day of June, 1995, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as "Nassau County", and ROCKY COLEMAN, whose post office address is 1307 Clinch Drive  
~~P.O. Box 1173~~, Fernandina Beach, FL 32034, hereinafter referred to as "Releasor".

In consideration of being permitted to conduct dog training/obedience classes at the Nassau County Animal Control Facility located at Yulee, Florida, Releasor, for himself and his personal representatives, assigns, heirs, and next of kin, releases, waives, discharges, and covenants not to sue Nassau County, including its Commissioners, officers and employees, from any and all liability Nassau County may have to Releasor, his personal representatives, assigns, heirs, and next of kin, for all loss or damage and any claim of damage therefore, on account of injury to Releasor or any person or animal or otherwise while Releasor is conducting dog training/obedience classes at the Nassau County Animal Control Facility.

Releasor agrees to indemnify Nassau County from any loss, liability, damage, or cost incurred by any individual participating in the classes/training or any animal participating in any particular classes/training.

Releasor agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida and that, if any portion of the

Agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Releasor, being of lawful age, in consideration of being permitted to conduct dog training/obedience classes at the Nassau County Animal Control Facility, does for himself, his heirs, executors, administrators, and assigns, hereby release and forever discharge Nassau County, its Commissioners, officers, and employees of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of Releasor's being permitted to conduct dog training/obedience classes at the Nassau County Animal Control Facility or any activities in connection with said activity, whether by negligence or not.

Releasor further states that he has carefully read the above release and knows the contents of the release and signs this release as his own free act.


Releasor further releases all Commissioners, officers, and/or employees of Nassau County from any claim whatsoever on account of first aid, treatment or service, rendered him or any members of his instruction classes during participation in said activity.

Releasor shall have each participant in the dog obedience/training classes execute a release as to Nassau County.


This release contains the entire agreement between the parties to this Agreement and the terms of this release are contractual and
