CONTRACT FOR SOLID WASTE SERVICES

This contract entered into on this date, <u>9-26-94</u>, by and between the Nassau County Florida Board of County Commissioners (COUNTY) and <u>Nassau Sanitation Services</u> (CONTRACTOR).

WHEREAS, the Board of County Commissioners has determined that it is economically advantageous to operate a Small Volume Dumping Area at the West Nassau Landfill, and,

WHEREAS, the Solid Waste Management Department wishes to provide a safe and easily accessible area for disposal of residential waste while enhancing the opportunity for citizens of Nassau County to recycle,

NOW THEREFORE, the parties agree as follows:

1. CONTRACTOR shall provide two 30 yard roll-off containers at the Small Volume Dumping Area at the West Nassau Landfill.

2. CONTRACTOR shall service these containers by pulling the containers, proceeding across the scales, disposing of the contenus at the working face of the landfill and returning the containers to the Small Volume Dumping Area.

3. COUNTY shall pay the CONTRACTOR \$_37.00 ____ for each full container serviced.

4. COUNTY shall pay the CONTRACTOR \$ 20.00 per container each month for rent and/or maintenance.

5. The CONTRACTOR shall respond to the COUNTY's request for service in a timely manner, but not less than one hour after being notified that container requires service.

6. CONTRACTOR shall provide the COUNTY with the date, time and weight of each container serviced when submitting monthly invoice for payment.

7. COUNTY shall maintain the area around the containers in a neat and orderly fashion, and insure the CONTRACTOR has access to the containers for servicing.

8. CONTRACTOR shall provide the COUNTY with the name(s) and telephone number(s) of individual(s) to contact during landfill operating hours for service.

9. This contract expires 9-30-95, unless either party terminates the contract with 24 hour written notice prior to that date.
