

FORM OF AGREEMENT


THIS AGREEMENT, made this 26th day of September, 1994, by and between the NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS, hereinafter called 'OWNER' and PGMS CORPORATION, doing business as a corporation hereinafter called 'CONSULTANT'.


WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:


1. The Consultant will be available to the Nassau County Engineering Department staff to conduct reviews of construction plans, permit applications, and other materials, for compliance with County Ordinances and Regulations, required to be reviewed pertaining to the daily operations of the Engineering Department.
2. The Consultant will make available his professional seal to certify and/or approve plans on behalf of Nassau County, if required.
3. The Consultant will perform said services in the best interest of Nassau County, as a representative of Nassau County.
4. The Consultant agrees to perform all of the work described in the Form of Agreement for the sum of \$75.00 per hour.
5. The Consultant agrees to perform said services commencing September 26, 1994, and ending September 30, 1994. Said period may be extended upon approval of the Consultant and the Board of County Commissioners.
6. The Owner will pay to the Consultant, after verification of hourly tabulations, such amounts as invoiced by the Consultant. Such invoice shall include the total number of hours, hourly rate, and period of invoice.
7. This agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.

IN WITNESS WHEREOF, the parties hereto have executed or caused to be executed by their duly authorized officials, this Agreement in triplicate each of which shall be deemed an original on the date first above written.






WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:


