- 5. The Consultant agrees to perform said services commencing September 26, 1994, and ending September 30, 1994. Said period may be extended upon approval of the Consultant and the Board of County Commissioners.
- 6. The Owner will pay to the Consultant, after verification of hourly tabulations, such amounts as invoiced by the Consultant. Such invoice shall include the total number of hours, hourly rate, and period of invoice.
- 7. This agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
