

Contract Agreement

THIS CONTRACT AGREEMENT, made this 7th day of April A.D., 1995, by and between the Nassau County, Florida, a N/A corporation, hereinafter called the OWNER and Walding Company, a Florida corporation, hereinafter called the CONTRACTOR.

WITNESSETH that for the consideration and under the provisions hereinafter stated and referred to moving from each to the other of said parties respectively, it is mutually understood and agreed as follows:

1. STATEMENT OF AWARD

The Contractor is the lowest and best responsible Bidder for furnishing all labor and materials, for construction of the Fernandina International Tradeplex Roadway Construction Project prepared by Pitman-Hartenstein & Associates, Inc., Engineers, for Nassau County, Florida, and has been awarded to the Contract for said work, the 27th day of March, 1995.

2. SCOPE OF WORK

The Contractor shall, at his own cost and expense, furnish all materials, tools, equipment, labor, and everything else necessary to perform and shall perform in accordance with the Contract Documents as defined in the paragraph of the Information for Bidders entitled "Contract Documents", all of which are hereby made a part of this Contract Agreement and are on file in the Office of the County Engineer, Fernandina Beach, Florida the work of accomplishing the construction of the Fernandina International Tradeplex Roadway Construction Project.

3. COMPENSATION

On the faithful and acceptable performance of this Contract Agreement by the Contractor, the Owner will pay the Contractor, in accordance with the Contract Documents, the total sum of

One Million, Forty-Two Thousand, Eight hundred forty dollars and seventy-five cents
(\$1,042,840.75)

JAW ~~which sum will be adjusted in accordance with equipment prices contained in the Contractor's Proposal and the actual material and equipment accepted and installed in accordance with the Contract Documents~~

4. TIME OF COMPLETION, LIQUIDATION DAMAGES AND INSPECTION COSTS

The Contractor hereby agrees to commence the work under this Contract Agreement on a date to be specified in a written "Notice to Proceed" of the Owner and to fully complete each subpart of the project within the consecutive calendar days shown below:

In the event final completion of the work is delayed beyond the time stipulated, or extension(s) of time granted by the Owner, the Contractor agrees to pay the Owner, as liquidated damages the sum of three hundred dollars (\$300.00) per day for each and every day thereafter, Sundays and holidays included, plus actual engineering inspection costs including support services for each and every day thereafter, Sundays and holidays included, until date of Final Acceptance by the Owner; notwithstanding issuance of a Certificate of Substantial Completion on the project.

This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
