Enclosed is my proposal for maintenance of the telephone equipment at the referenced buildings.

The proposal reflects the same charge per phone as we "contracted" on for the 1994-1995 year.

This year, the county has added a total of (8) phones in the Annex and Building Department buildings and (41) phones at the Courthouse are not "covered" by a warranty as they were in 1994-1995.

We are now maintaining a similar amount of phones as the 1993-1994 year when the amount was (124) phones for a maintenance contract price of \$3375.00.
