

## CONTRACT

THIS AGREEMENT made and entered into between the *Nassau County Board of County Commissioners*, whose address is Post Office Box 1010, Fernandina Beach, Florida 32035, hereinafter called the "County", and *Michael A. Berg & Associates*, whose address is 5615 San Juan Avenue, No. 608, Jacksonville, Florida 32210, hereinafter called "Berg".

WHEREAS, pursuant to Case No.96-468-Civ-J-20B, pending in the Federal court, the county has accepted Michael Berg as an expert; and

WHEREAS, the County has a committee formed to evaluate the present utilization of the Nassau County Correctional Facility; and

WHEREAS, it is in the best interest of the county to retain the services of Berg and his associate to review and make recommendations regarding the utilization of the existing correctional facility and/or recommendations as to the proposed new correctional facility.

For and in consideration of the sum of Ten and No/100 dollars (\$10.00) and other mutually agreed upon considerations, the parties agree as follows:

1. The County agrees to retain the services of Michael Berg and his associate.

2. The term of this agreement shall be for a period of not less than 120 days and for additional periods as are mutually agreed upon by the parties.

3. Berg and his associate will consult with and provide written recommendations and oral recommendations to the county regarding the pending lawsuit and utilization of the correctional facility during the construction period of the new correctional facility and recommendations as to the proposed facility as requested by the County.

4. Berg and his associate will be compensated at the rates as set forth in the attached Exhibit "A".


5. The contact person for the county shall be Undersheriff Tommy Reeves. The Undersheriff shall authorize specific items to be performed by Berg and shall advise Mr. Gossett of each and every request.

6. All statements for services rendered shall be sent to the County Coordinator Walter D. Gossett at Post Office Box 1010, Fernandina Beach, Florida 32035 and said bills will be reviewed and authorized by the Undersheriff and Mr. Gossett and, if approved, paid within thirty (30) days of the invoice.

7. Berg and his associate will attend any and all meetings of the Jail Committee.

8. This contract may be terminated by the County upon ten (10) days written notice. Any monies due Berg shall be paid within thirty (30) days of termination.


