

## FORM OF AGREEMENT

THIS AGREEMENT, made this 22nd day of January, 1996,<sup>7</sup>  
by and between Nassau County Board of Commissioners, hereinafter called "OWNER",  
and **J. B. COXWELL CONTRACTING**  
doing business as (an individual, partnership, or corporation) hereinafter called  
"CONTRACTOR".


WITNESSETH: That for and in consideration of the payments and agreements  
hereinafter mentioned.

1. The CONTRACTOR will commence and complete the contract for Mill's Creek Watershed Maintenance, Phase I.
2. The CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor and other services necessary for the construction and completion of the PROJECT described herein.
3. The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS within twenty (20) calendar days after the date of the NOTICE OF AWARD and will complete the same within 100 calendar days after the date of the NOTICE OF AWARD unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
4. The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENT and comply with the terms therein for the **Unit Price of \$3,300.00 Per Acre** as shown in the Proposal Schedule with a total contract cost **Not To Exceed \$38,000.00**.
5. The term "CONTRACT DOCUMENTS" means and includes the following:
  - (A) Advertisement for Bids
  - (B) Proposal
  - (C) Agreement
  - (D) Performance Bond
  - (E) Notice of Award
  - (F) Drawings of Mill's Creek Watershed
  - (G) Specifications prepared and/or issued by Nassau County
  - (H) Addendum
  - (I) Public Entities Crime Form
  - (J) Conflict of Interest Form
6. The OWNER will pay to the CONTRACTOR in the manner and at such times as set forth in the General Conditions such amounts are required by the Contract Documents.

7. This agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.


IN WITNESS WHEREOF, the parties hereto have executed or caused to be executed by their duly authorized officials, this Agreement in triplicate each of which shall be deemed an original on the date first above written.


