Dear John,

Pursuant to our proposal of October 15, 1997, Superior Construction will Cofferdam the creek with clay on the upstream and downstream of the culvert and pump out the culvert for inspection for the Lump Sum of \$ 23,100.00.


If after inspection, it appears the integrity of the box culvert is acceptable then we will pump fine aggregate, 2000 psi grout into the void under the slab. This will be done for the price of \$330.00 per cubic yard. (Approximate Cost: \$26,400.00, based on 80 cys)

Any silt which needs to be removed from the box by means of a vacuum truck will be removed at the rate of \$275.00 per hour. (Approximate Cost: \$ 2,750.00, based on 10 hours)


Should other work be necessary, a separate agreement will be executed.

This work will commence immediately and will continue until all work is complete.


