
CONTRACT SOLINET MEMBERSHIP AGREEMENT

The Southeastern Library Network ("SOLINET") will provide Nassau County Public Library System with access to SOLINET services and products under the terms and conditions specified herein and as may otherwise be set forth by SOLINET in its written procedures and policies governing SOLINET membership and participation:

1. Member agrees to abide by the SOLINET Bylaws.
2. Member agrees to pay SOLINET for services, products, and support fees in accordance with the latest schedule of charges appropriate as published by SOLINET and invoiced by SOLINET. All charges billed monthly shall be due thirty (30) days from the date of the invoice reflecting such charges. A one percent (1%) per month service charge shall be automatically assessed against any and all charges which are not fully paid within thirty (30) days of date of invoice.

This Agreement shall take effect upon the latest date of execution below by duly authorized representatives of the library and SOLINET and shall automatically renew annually on the first day of July, except as otherwise provided in the bylaws.



CONTRACT AGREEMENT ON USE OF OCLC SERVICES

The Southeastern Library Network ("SOLINET") will provide Nassau County Public Library System with access to OCLC services and products under the terms and conditions specified herein and as may otherwise be set forth by SOLINET in its written procedures and policies governing SOLINET membership and service participation:

1. This Agreement is dependent upon the continued contract between SOLINET and the OCLC Online Computer Library Center, Inc. ("OCLC") to make available online bibliographic services and products. Should this contract ever expire, SOLINET will notify member as soon as possible so that member can make other arrangements for services.
2. Member agrees to use the OCLC Online Cataloging System in accordance with The OCLC Online Union Catalog: Principles of Cooperation for OCLC and Member Libraries which is attached and made part of this Agreement by this reference. The OCLC/SOLINET contract states that holdings representing all current cataloging be set on the OCLC system regardless of source.
3. Member agrees to abide by the standards set forth in the document Bibliographic Formats and Standards (latest edition), and to use and transfer records obtained from the OCLC Online Union Catalog in accordance with the document Principles and Guidelines for Transfer of OCLC -Derived Machine Readable Records (latest edition).
4. Member agrees to observe the terms and conditions of licensing agreements required by OCLC for use of specific products, services and equipment obtained by User through purchase, loan or lease.


