

**INTERLOCAL AGREEMENT**

WHEREAS, Nassau County provides animal control for the unincorporated areas of the County; and

WHEREAS, the Town of Callahan has requested that the County provide animal control services within the incorporated areas of the Town of Callahan; and

WHEREAS, both the Board of County Commissioners of Nassau County and the Town Council of the Town of Callahan believe that this would be in the best interest of the County and the Town of Callahan.

WHEREAS, the Town of Callahan believes that the animal control laws adopted by the Board of County Commissioners should be enforced within the corporate limits of the Town of Callahan.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the sum of Ten and no/100 dollars (\$10.00) and other mutually agreed upon consideration, the parties agree as follows:


1. The Board of County Commissioners of Nassau County shall provide animal control services, through its Animal Control Department within the incorporated areas of the Town of Callahan.
2. The animal control ordinances of Nassau County shall be enforced within the corporate limits of the Town of Callahan.
3. The Town of Callahan shall pay to the Board of County Commissioners, as and for said services, an amount equal to the total Animal Control budget for the county divided by the number of persons served in the

Municipal Service Benefit District (to determine a per capita cost) times the population of the Town. Said amounts shall be paid in quarterly installments, commencing December 31, 1998.


4. The term of this agreement shall be October 1, 1998 through September 30, 1999.

5. This agreement shall become effective upon being signed by the Chairman of the Board of County Commissioners and the Mayor of the Town of Callahan.






