RE: REVISION TO COST PROPOSAL FOR ADDRESSING POTENTIAL LANDFILL GAS MIGRATION WEST NASSAU CLASS I LANDFILL NASSAU COUNTY, FLORIDA

Dear Mr. Oxley:

Golder Associates Inc. (Golder) has prepared this revised cost proposal as requested by the Nassau County Board of County Commissioners (Board) in its meeting of July 12, 1999. This cost proposal was originally submitted to the Board in a letter dated June 9, 1999, and in its meeting of June 21, 1999 the Board approved Task 1 of the scope only, with the provision to approve the remainder of the work based on completion of Task 1 and a verbal report on the findings. The cost proposal is for professional services to address the issue of potential landfill gas migration (principally the source of the gas) at the West Nassau Class I Landfill in Nassau County, Florida.

As reported on July 12, 1999, our data review indicated that the source of the gas detected in several probes around the landfill is likely municipal solid waste. The original cost proposal included a field program as Task 2 to assist in determining the source of the gas. However, the data review indicated that the field effort could be greatly reduced. Therefore, this revised cost proposal includes a reduced effort and cost (from \$7,505 to \$2,000) for Task 2. Commensurate with the reduction in field effort, the estimated effort for Task 3 (Reporting) has also been reduced (from \$4,390 to \$2,395). Task 1 (which has been completed) has not been changed. As shown in the attached Table 1, the total not-to-exceed amount for the revised scope of work is now \$5,980.00. All other terms and conditions of the original cost proposal remain in effect.

As discussed in the July 12, 1999 meeting, we are submitting this revised cost proposal to you (Mr. Oxley) with the understanding that you will have Chairman Cooper approve the revised cost proposal based on authority from the Board.
