

AGREEMENT


THIS AGREEMENT made this 22nd day of March, 1999 by and between the Board of County Commissioners of Nassau County, Florida, whose address is Post Office Box 1010, Fernandina Beach, Florida 32035, and Adrian Lee Patrick, Jr., and Brenda W. Patrick, his wife, whose address is Post Office Box 757, Callahan, Florida 32011.

FOR AND IN CONSIDERATION of the sum of Ten and No/100 Dollars (\$10.00), the parties agree as follows:

1. Mr. and Mrs. Adrian Lee Patrick, Jr., shall move their mobile home from the existing county property within 30 days of March 9, 22, 1999. Mr. and Mrs. Patrick are responsible for contracting with a company to accomplish the move.
2. The Patricks shall not leave any debris or other items on the county property and shall only move the mobile home that is presently located on the County property.
3. The County shall pay the sum of \$3,300.00 to the Patricks, which is for the purpose of moving the trailer, hooking it back up and installing skirting. Said amount shall be paid upon the joint execution of this Agreement.
4. This Agreement represents the entire obligation of the County and the Patricks.
5. If legal action is necessary to enforce the terms of this Agreement then the prevailing party shall be entitled to attorneys' fees and costs and pre-judgment interest.
6. By acceptance of the \$3,300.00 and the execution of this Agreement, the Patricks agree to the provisions of this Agreement. Should the Patricks fail to comply with any provision of this Agreement, the entire amount of \$3,300.00 shall be repaid to the County within ten (10) days of the date of the breach.






