

**WASTEWATER SERVICE AGREEMENT**

Applicant hereby requests wastewater utility service from UNITED WATER FLORIDA INC., ("Service Company") and agrees to abide by the following terms and conditions.

1. United Water Florida Inc., whose address is 1400 Millcoe Road, Jacksonville, Florida 32225, hereinafter referred to as "Service Company," shall supply wastewater service at the premises noted herein and Applicant promises to purchase wastewater utility service and **pay Service Company therefore in accordance with Service Company's schedule of rates** which shall from time to time be legally in effect and applicable to the service applied for, and to conform to and abide by Service Company's rules and regulations in force relating to such service approved by the Florida Public Service Commission.
2. Service to be provided under this agreement is limited to : (1) Fire Station located at : 4061 Pine Grove Rd., Yulee, Florida
3. At execution of this agreement, Applicant shall pay to Service Company the contribution to utility plant and wastewater service line (if applicable) as currently approved by the Florida Public Service Commission in Service Company's Tariff. Said contribution is presently as follows:

WASTEWATER - \$370 per Equivalent Residential Connection or \$555 for 1.5 ERC's

TOTAL COSTS OF ITEMS IN PARAGRAPH THREE (3) .....\$555.00

4. Any additional connections to this system will require Service Company's prior approval, which shall not be unreasonably withheld, and payment of additional connection fees in the amount approved by appropriate regulatory agencies at that time.
5. This Agreement shall inure to and be binding upon the successors and/or assigns of the parties hereto.
6. Applicant shall remain liable and responsible for making payment to Service Company for all wastewater utility services provided hereunder until Applicant's successor or assigns shall make a separate application for service as a new customer and is accepted as a new customer by service Company..
7. Wastewater service rendered under this Service Contract shall be in accordance with the Service Availability Policy approved by the Florida Public Service Commission.
8. Service Company shall have the right to refuse to provide service to any building until Applicant complies with all of the terms and conditions of this agreement..
9. ***Applicant shall communicate to United Water Florida's Billing Department, at least 2 days prior to connection of above properties into United Water Florida's system***, the service address of said properties and any other pertinent information that United Water Florida will need to begin monthly billing of properties.
10. ***An AS-BUILT*** sealed by a registered Florida Surveyor, will be submitted to UWFL at the completion of construction, showing improvements from the point of connection to UWFL main/s to sewer pump out shown on approved plans.
