AGREEMENT

THIS AGREEMENT made and entered into this 1st day of October, 2000, by and between the County of Nassau, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and the Association of Retarded Citizens, referred to as ARC/NASSAU.

WITNESSETH

WHEREAS, it is in the best interest of the citizens of Nassau County that the ARC/NASSAU program continue, and work with the mentally retarded citizens of Nassau County, and

WHEREAS, the ARC/NASSAU program now maintains a program and headquarters for the retarded of Nassau County;

NOW, THEREFORE, the parties hereto agree as follows:

1. For and in consideration of the sum of \$42,527, which shall be paid in quarterly installments, during the months of November, February, May and August, the ARC/NASSAU program does hereby agree to perform services that will benefit the residents of Nassau County. Said services to include but not be limited to the following:

a. Continuing the present level of services provided for the mentally retarded at the ARC/NASSAU'S main center.

2. The ARC/NASSAU program shall make their financial records available to the COUNTY for purposes of an audit, if requested by the COUNTY. The COUNTY shall require an audit of previous year's financial records to be performed by an independent accounting firm. The audit report must be presented to the COUNTY before the May distribution will be made.

3. All facilities, programs and services should be compliant with the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA).




