

AGREEMENT

THIS AGREEMENT made and entered into this 1st day of October, 2000, by and between the County of Nassau, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and the Friends of the Carpenter, hereinafter referred to as FRIENDS OF THE CARPENTER.

WITNESSETH

WHEREAS, it is in the best interest of the citizens of Nassau County that there be a FRIENDS OF THE CARPENTER organization.

WHEREAS, the FRIENDS OF THE CARPENTER offers the community hope for safe, secure homes for those unable to help themselves because of age, physical infirmity, or other handicap; hope for individual economic betterment; and hope for healthier, drug free living.


NOW, THEREFORE, the parties hereto agree as follows:

1. For and in consideration of the sum of \$5,000.00, which shall be paid in quarterly installments, during the months of November, February, May and August, the FRIENDS OF THE CARPENTER does hereby agree to perform services that will benefit the residents of Nassau County. Said services to include but not be limited to the following:
 - a. Continue the present level of services provided for needy individuals in the community.
2. The FRIENDS OF THE CARPENTER shall make their financial records available to the COUNTY for purposes of an audit, if requested by the COUNTY. The COUNTY shall require an audit of previous year's financial records to be performed by an independent accounting firm. The audit report must be presented to the COUNTY before the May distribution is made.
3. All facilities, programs, and services should be compliant with the Florida Accessibility Code and the federal Americans with Disabilities Act.
