THAT PORTION OF THE FOLLOWING DESCRIBED PARCEL OF LAND, 60 FEET IN WIDTH, LYING AND BEING WITHIN LANDS CONVEYED IN OFFICIAL RECORD BOOK 324, PAGE 867, OF THE PUBLIC RECORDS OF NASSAU COUNTY, FLORIDA, ALSO BEING IDENTIFIED BY THE PROPERTY APPRAISER OF NASSAU COUNTY, FLORIDA, AS PARCEL (43-2N-28-0000-0001-0090).

A 60.00 FOOT WIDE STRIP OF LAND, FOR RIGHT-OF-WAY PURPOSES, LYING 30.00 FEET ON EACH SIDE, WHEN MEASURED AT RIGHT ANGLES TO, THE FOLLOWING DESCRIBED CENTERLINE:


COMMENCE AT POINT OF CURVATURE STATION 126+72.99, AS SHOWN ON RIGHT-OF-WAY MAP FOR COUNTY ROAD NO. 107, AS RECORDED IN ROAD PLAT BOOK 6, PAGES 85 THROUGH 94, PUBLIC RECORDS OF NASSAU COUNTY, FLORIDA; THENCE NORTH 04°39'32" WEST, ALONG THE CENTERLINE OF SAID COUNTY ROAD NO. 107, A DISTANCE OF 304.56 FEET TO THE INTERSECTION OF FRANK WARD ROAD (A PROPOSED 60 FOOT RIGHT-OF-WAY, CURRENTLY A VARIABLE WIDTH, COUNTY MAINTAINED DIRT ROAD AND THE POINT OF BEGINNING; THENCE ALONG SAID CENTERLINE OF FRANK WARD ROAD, SOUTH 86°02'55" EAST, 296.52 FEET TO THE POINT OF CURVATURE, OF A CURVE CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 615.11 FEET, A CENTRAL ANGLE OF 27°24'32" AND BEING SUBTENDED BY A CHORD BEARING AND DISTANCE OF SOUTH 72°20'39" EAST, 291.46 FEET; THENCE SOUTHEASTERLY AROUND SAID CURVE TO THE RIGHT, AN ARC DISTANCE OF 294.26 FEET TO ITS POINT OF TANGENCY; THENCE SOUTH 58°38'23" EAST, 819.70 FEET TO THE POINT OF CURVATURE, OF A CURVE CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 2956.05 FEET, A CENTRAL ANGLE OF 16°21'47" AND BEING SUBTENDED BY A CHORD BEARING AND DISTANCE OF SOUTH 50°27'29" EAST, 841.35 FEET; THENCE SOUTHEASTERLY AROUND SAID CURVE TO THE RIGHT, AN ARC DISTANCE OF 844.21 FEET TO THE TERMINUS POINT OF THIS DESCRIPTION.
