Dear Jack:

The Modifications to the Courthouse functions discussed in the meeting with Judge Foster are changes to our contract based on the original plan signed off by Chip Oxley on February 25, 2000. At the time the plan was submitted, PQH/V pointed out there was no holding cell included in the plan due to the space being used for HVAC equipment. All exterior doors were to be accessible to the public with the exception of the side door to the Clerks Office and the door to the south end of the historic main hall in the old Courthouse, which were designated for employees. We were advised that metal detectors and x-ray equipment would not be required and that individuals going to the courtroom would be wanded to check for firearms. We even located a bailiff outside Judge Foster's office as a control point for the Judge and courtroom.

The additional scope involves the following:

- Architectural redesign
- Civil to amend permit with St. Johns River Water Management District
- Mechanical (Plumbing, HVAC) and Electrical Re-Engineering
- · Resubmittal for accessibility review
- Resubmittal to the Fire Marshal for review
- Resubmittal for permitting
- Construction coordination

After our meeting with Judge Foster on 5/30/01 we modified the second floor plan to incorporate a holding cell and restroom facility and sketches for the parking area in the rear as discussed at the meeting. Furthermore we have submitted the proposed revisions to Tony Jarzyna and Jeffrey L. Bunch for their review of ADA and Fire Safety issues. The attached plan and sketch meet the requirements of ADA and Fire Safety with an "area of refuge" provided with stairs at the back of the old Courthouse in lieu of the handicap ramp (see attached correspondence). Our costs and that of consultants have been kept to a minimum and are as follows:

- Architectural re-design \$2,500.00
- Coordination \$1,000.00
- Re-submittals and Permitting \$1,500.00
- Civil Permitting \$500.00
- Mechanical (HVAC/Plumbing) and Electrical \$4,100.00
- Construction Coordination \$1,000.00

Total additional cost for the proposed revisions: \$10,600.00

A rapid approval of our proposal will keep the project moving forward without delays. Please respond at your earliest convenience.
