MODIFICATION NUMBER ONE TO SUBGRANT BETWEEN THE DEPARTMENT OF COMMUNITY AFFAIRS AND THE COUNTY OF NASSAU

This Modification is made and entered into by and between the State of Florida, Department of Community Affairs, ("the Department"), and the Board of County Commissioners of the County of Nassau ("Recipient") to modify DCA Contract Number 01DB-79-04-55-01-E 40, dated June 21, 2001 ("the Agreement").

WHEREAS, the Department and the Recipient have entered into the Agreement, pursuant to which the Department has provided a grant of \$570,000.00 to Recipient; and

WHEREAS, the state administrative rule for the Small Cities Community Block Grant Program (Rule Chapter 9B-43, Florida Administrative Code) was amended subsequent to the commencement date of the Agreement; and

WHEREAS, the Department and the Recipient desire to have the Agreement and all implementation of the Agreement henceforth be governed by Rule Chapter 9B-43, Florida Administrative Code, as modified and effective on March 28, 2002.

NOW, THEREFORE, in consideration of the mutual promises herein contained, the Recipient and the Department hereby agree to amend the above described Agreement as follows:

The Department and Recipient agree that the Agreement shall henceforth be governed by the provisions of Rule Chapter 9B-43, Florida Administrative Code, as modified and effective March 28, 2002.

Except as modified herein, all other terms and conditions of the contract shall remain in full force and effect.
