Dear Sirs and Madams,

This letter represents the calculation of the audit fee for the 2002 - 2003 fiscal year based upon the provisions of our contract, dated April 30, 2001, for auditing services with the Board of County Commissioners.

The 2002 - 2003 audit fee is based upon the percentage increase or decrease in operating expenditures of the general, special revenue, debt service, and enterprise funds. However, this percentage increase or decrease is limited to 8% of the previous year's contract amount. The contract amount for the previous year (2001 - 2002) was \$93,040 plus out-of-pocket expenses.

The change in the operating expenditures is calculated using the previous two (2) years audited financial statements. The audit fee for the 2002-2003 fiscal year is calculated as follows:

The above tabulation does not include any expenditures in the capital projects funds which totaled \$19,847,839 or the agency funds which totaled \$101,432,155 because there are no operating expenditures in these funds.

Accordingly, the change in operating expenditures for the 2001-2002 fiscal year over the 2000 - 2001 fiscal year was an increase of \$12,502,996 as shown above. This calculates to an increase of 23.535% (\$12,502,996 - \$53,125,258). Therefore, the contract amount will be limited to 8% as stated above, or \$7443. Accordingly, the total contract amount for the fiscal year ending September 30, 2003 will be \$100,483 plus out-of-pocket expenses.


