AGREEMENT

THIS AGREEMENT entered into this <u>28th</u> day of April, 2003, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the TOWN OF HILLIARD, a Florida municipality, hereinafter referred to as the "Town".

WHEREAS, the Town of Hilliard, due to security requirements pursuant to a Florida Department of Transportation (FDOT) grant, is fencing sections of the Hilliard Airpark; and

WHEREAS, FDOT requires that the fence to the west of the runway be located one hundred (100) feet from the runway edge; and

WHEREAS, in order for the fence to be located one hundred (100) feet from the runway edge, it must be placed on County property.

NOW, THEREFORE, FOR and IN CONSIDERATION of ten and no/100 dollars (\$10.00) and other mutually agreed upon consideration, the parties agree as follows:

1. The Town shall be allowed to erect a fence one hundred (100) feet from the runway edge to where the tree line exists as of the date of this Agreement.

2. The County grants a license to the Town to place the fence on County property.

3. The Town shall maintain the fence and the grounds on either side of the fence as approved by the County.

4. The Town shall hold the County harmless from any and all liability for any and all claims that arise based upon the fence. The indemnification shall include all fees and costs, including attorney's fees.

5. The erection of the fence shall not impede the County's access to the Road and Bridge buildings or grounds. Access shall be provided, as deemed necessary by the County, to the one hundred (100) foot section of County property.

The plans and placement of the fence shall be 6. to Florida Department of pursuant Transportation and Federal Aviation Authority regulations and subject to review by the County's Engineering Department, the Supervisor of the County's Road and Bridge Department, and the Director of the Buildings Maintenance Department prior to construction.

7. The Town hereby acknowledges that this is a license and makes no claim, now or in the future, to ownership or possession of the property by virtue of placing the fence on the County's property.

8. A breach of this Agreement may result in the removal of the fence, and if either party breaches this Agreement, the prevailing party in mediation or litigation shall be entitled to attorney's fees and costs.

9. Time is of the essence.

10. This is the entire Agreement, and any amendment to this Agreement shall be in writing and executed by both parties.
