RENEWAL OF LEASE AGREEMENT

THIS LEASE AGREEMENT entered into this 30th day of September , 2002, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU, COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as the "COUNTY", and the SALVATION ARMY, hereinafter referred to as the "ARMY".

FOR AND IN CONSIDERATION of ten and no/100 Dollars (\$10.00), and other mutually agreed upon consideration, the parties agree as follows:

- The County agrees to lease to Army approximately four hundred fifty (450) square feet at the temporary location of the Nassau County Courthouse.
- 2. The rental amount shall be six hundred fifty and no/100 dollars (\$650.00) per month. All utilities are included in the rental amount except for telephone services.
- 3. The rental term shall be for a period October 1, 2002 through September 30, 2003. Additional rental terms for one (1) year periods may be negotiated between the parties at least thirty (30) days prior to the end of the rental term.
- 4. The Army shall be responsible for cleaning services within the demised premises. Amy shall ensure that any individuals or companies performing cleaning

services comply with all security requirements as established by the County.

- 5. The Army agrees that there shall be no clients in the building except during regular working hours. The Army also agrees that all its employees and clients will comply with any and all security requirements for the building.
- 6. The interior of the leased premises shall be compliant with the Florida Accessibility Code and the programs and services shall be in compliance with the Federal Americans with Disabilities Act (ADA).
- 7. This Agreement may be terminated by either party by providing thirty (30) days written notice.
- 8. Army shall hold the County harmless from any and all liability as regards the utilization of the demised premises.
- 9. Time is of the essence.
