

SINGLE ADVANCE LOANS - If this is a single advance loan, you and I

MULTIPLE ADVANCE LOANS - If this is a multiple advance loan, you and I expect that you will make more than one advance of principal. If this is closed end credit, repaying a part of the principal will not entitle me to additional credit.

"Right to receive money from you" means:
