# **Memorandum of Agreement**

#### Sutton Place Behavioral Health, Inc. In partnership with Family Matters of Nassau County

This agreement is entered into between Sutton Place Behavioral Health, Inc. (SPBH) and Family Matters of Nassau County (FMNC). This agreement shall be effective July 1, 2005, or upon signature of all parties to June 30, 2008, and may be renewed annually thereafter by mutual consent of the parties hereto.

#### **Background on Sutton Place Behavioral Health:**

Sutton Place Behavioral Health, Inc. is a not-for-profit organization founded in 1992. SPBH operates from three main offices located throughout Nassau County – Fernandina Beach, Yulee, and Hilliard. SPBH provides mental health counseling, psychiatric care, substance abuse and other services to a diverse clientele throughout the county. Since it's founding more than 10,000 Nassau County residents have been helped. Our mission is to provide the highest quality mental health and addiction services for the residents of Nassau County.

SPBH provides services to Nassau County residents. SPBH offers services to individuals and families with mental health and/or substance abuse disorders or those who are at risk of developing a disorder. A voluntary assessment is conducted to determine the need for SPBH services. If the assessment determines services are needed, and the individual/family volunteers to participate, the client will be enrolled in our system for continued services. If SPBH is at capacity the person will be placed on a waiting list. SPBH will provide the client referrals and information on community resources, depending on the needs of the client. SPBH will attempt to place all those who are in emergent need of services. Pregnant and post-partum women will be given the highest priority. SPBH offers the following services:

- Adult outpatient mental health
- Adult substance abuse
- Adult psychosocial rehabilitation
- Case management
- Children's outpatient mental health

- Children's prevention
- Children's substance abuse
- Prevention and Community Education
- Psychiatric evaluations and medication management
- Socialization Programs
- 24-hour Emergency Services

Some families may need services beyond those offered through SPBH. These services, such as domestic violence intervention, residential services, medical services and protective supervision, fall outside the scope of SPBH. SPBH relies upon strong partnerships in the community to provide these types of services.

SPBH offers a sliding fee scale for all mental health services, based on client's ability to pay, and a flat rate for all substance abuse services. Medicaid, Medicare, private insurance and third party payor are accepted.

SPBH agrees to provide emergency psychiatric services, when possible, at a cost of sixty dollars per twenty-minutes of care, to be paid by FMNC.

### **Background on Family Matters of Nassau County:**

The Florida Department of Children and Families contracted the Nassau Board of County Commissioners to be the lead agency to assume responsibility for and oversight of all post protective child investigative services in Nassau County, Florida. FMNC will provide temporary shelter care, protective supervision, foster care and adoption services to children considered at risk of abuse, neglect and abandonment.

### **Purpose:**

SPBH and FMNC are partners in strengthening and supporting families. SPBH and FMNC are committed to working together to provide a continuum of care to families residing in their community. When SPBH and FMNC are both providing services to a given family, SPBH and FMNC will mutually support each other's role through collaborative planning for prevention and early intervention of child abuse and neglect. The purpose of this agreement is to outline the responsibilities for SPBH and FMNC collaboration.

### **Mutual Responsibilities:**

- 1. SPBH and FMNC will promote collaboration and provide opportunities for collaborative input by agreeing to serve and participate on each other's advisory council.
- 2. Should SPBH and FMNC provide services to a family at the same time, SPBH and FMNC will be mutually responsible for maintaining coordination of services to the family and maintaining routine contact (minimum of once a month) to discuss the family's progress as long as both agencies serve the family. FMNC and SPBH agree to participate in periodic staffings (with family's participation, when appropriate) to discuss the progress of the family and to support each agency's role in working with the family. On an individual case basis, FMNC and SPBH may develop a written agreement outlining specific roles each may play in providing service to the family.
- 3. To facilitate communication between FMNC and SPBH, SPBH and FMNC will each designate a liaison for SPBH and FMNC contacts.
- 4. SPBH and FMNC agree to respect the confidentiality of the family. Information may be shared between FMNC and SPBH if the agency providing the information has a signed Consent for Release of Information form from the family. Information to be shared may include information related to the general care of children, parenting skills, risk factors, progress toward treatment goals, test results, medication compliance, and treatment compliance.
- 5. SPBH and FMNC will provide ongoing training about their programs to one another as the need arises.
- 6. SPBH and FMNC will share training opportunities that may enhance the knowledge or skills of staff from SPBH or FMNC.

All terms of this agreement are fully understood and accepted by FMNC and SPBH and their respective service providers as represented by the signers of this agreement. Any modifications to this agreement will be made in writing with the consent of all parties.

### **General Conditions:**

- Amendments. No modification or amendment in the conditions contained herein shall be effective unless contained in a written document and executed by each Party hereto.
- **Termination.** Either Party may cancel this Agreement during the term hereof upon thirty (30) days notice to the other Party of its desire to terminate the Agreement.
- Authority. Each person signing this Agreement on behalf of either Party individually warrants that he or she has full legal power to execute this Agreement and to bind and obligate said Party with respect to all provisions contained in this Agreement.


