LICENSE AGREEMENT

THIS LICENSE AGREEMENT entered into this $\int J$ day of July, 2005, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, hereinafter referred to as the "County", and the **WATERTOP UNLIMITED**, **LLC**, **a Florida limited liability corporation**, hereinafter referred to as "Watertop".

1. Watertop desires to utilize the Nassau County North End Boat Ramp for its 2005 Florida PWC Rally Series -Amelia Island ("Rally") on September 10-11, 2005, and the County agrees to grant Watertop a license to do so.

2. Watertop shall indemnify and hold the County harmless from any and all liability arising from the use of the North End Boat Ramp during its Rally. Said indemnification shall include, but not be limited to, claims, if any, from participants or spectators during the period from September 10-11, 2005, and costs and expenses associated with said claims.

3. Watertop acknowledges that the Park is open to the public, and that the public will also be utilizing the Park during the time that the event occurs at the Park.

4. Watertop shall provide the County's Parks and Recreation Department, 45195 Musselwhite Road, Callahan, FL 32011, at least ten (10) days prior to September 10, 2005, with a copy of its liability insurance indicating Nassau County as an additional insured for a minimum of \$1 million dollars.

5. Watertop shall provide information to all participants of underwater hazards that may cause damage to vessels at low tide at the boat ramp and shall be responsible for any and all claims from person(s) participating in the Event.

6. The area shall be left in the same condition of cleanliness as it is found and all trash must be placed in the trash containers. Any litter and debris pick-up shall be the responsibility of Watertop during the time of the tournament.

7. The Parks and Recreation Department shall provide all of the existing County Ordinances regarding public areas to Watertop at least thirty (30) days prior to September 10, 2005.

8. No alcoholic beverages shall be consumed in the Park area.

9. The license may be revoked at any time by the County Administrator.

10. A deposit of \$100.00 shall be paid to the Clerk's Office, 76347 Veterans Way, Yulee, FL 32097, and shall be refundable within thirty (30) working days following the review of the Parks and Recreation Department that the terms of this License Agreement have been met.

11. The County Administrator shall hear any dispute as to the return of the deposit.

12. Watertop, by signing this License Agreement, acknowledges that its representative has the authority to sign on its behalf, and, further, that the representative understands the Agreement and agrees to the terms.


