#### AGREEMENT

THIS AGREEMENT entered into this <u>9th</u> day of March, 2005, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as the "County", and EMERGENCY RESPONSE EDUCATORS AND CONSULTANTS, INC., a Florida corporation, hereinafter referred to as "EREC".

FOR and IN CONSIDERATION of ten and no/100 dollars (\$10.00) and other mutually agreed upon consideration, the parties agree as follows:

1. EREC shall perform the work set forth in the attached Exhibit "A". Said work shall be performed and final written recommendations to the County on or before September 20, 2005.

2. EREC shall be paid the sum of four thousand and no/100 dollars (\$4,000.00) to perform the work.

3. EREC shall be paid said sum upon the completion of the work and the approval of the County Administrator and the Director of Emergency Management.

4. Any dispute arising under this contract shall be addressed in the following manner: The County Administrator and the Director of Emergency Services shall meet with EREC to address any disputes. Said meeting shall occur within ten (10) days of the date of either party

requesting the meeting. The parties shall make every effort to resolve any dispute. If the dispute cannot be resolved by the parties at a meeting or subsequent meetings, the parties shall proceed to mediation. Mediators shall be chosen from the Supreme Court approved list of mediators in the Fourth Judicial Circuit, and the cost of mediation shall be borne by EREC. If the matter is not resolved at mediation, either party may seek relief through the appropriate Court. If mediation is ordered by the Court, EREC shall be responsible for the costs of mediation.

5. Time is of the essence.

#### **Review of plans for NIMS compliance recommendations**

Review Nassau County emergency response agencies' policies, plans, procedures and training for emergency preparedness, response, recovery and mitigation in order to ensure the County complies with HSPD-5, *Management of Domestic Incidents* and the *National Response Plan (NRP)*. The review will be developed in accordance with the above-mentioned Department of Homeland Security initiatives and guided by the National Incident Management System Capability Assessment Support Tool (NIMCAST).

The *NRP* requires all Federal, State, Local and Tribal agencies to adopt the NIMS and use it in their individual domestic incident management and emergency prevention, preparedness, response, recovery, and mitigation activities, as well as in support of all actions taken to assist State or other local entities on or before September 2005. EREC will review the policies, plans, procedures and training for the Nassau County Emergency Management Department, Nassau County Fire & Rescue Department, Nassau County Sheriff's Office, and provide detailed written recommendations for NIMS compliance.
