#### LICENSE AGREEMENT

THIS LICENSE AGREEMENT entered into this <u>9th</u> day of March February, 2005, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the INSHORE FISHING ASSOCIATION, INC., a Florida corporation, hereinafter referred to as "Inshore".

FOR and IN CONSIDERATION of ten and no/100 dollars (\$10.00) and other mutually agreed upon consideration, the parties agree as follows:

1. Inshore desires to utilize the Nassau County North End Boat Ramp for its 2005 Redfish Tournament on August 20, 2005, and the County agrees to grant Inshore a license to do so.

2. Inshore shall hold the County harmless from any and all liability arising from the use of the North End Boat Ramp during its Redfish Tournament.

3. Inshore shall provide the County's Parks and Recreation Department, 45195 Musselwhite Road, Callahan, FL 32011, at least ten (10) days prior to August 20, 2005, with a copy of its liability insurance indicating Nassau County as an additional insured for a minimum of \$1m.

4. Inshore shall provide information to all participants of underwater hazards that may cause damage to vessels at low tide at the boat ramp.

5. The area shall be left in the same condition of cleanliness as it is found and all trash must be placed in the trash containers. Any litter and debris pick-up shall be the responsibility of Inshore during the time of the tournament.

6. The Parks and Recreation Department shall provide all of the existing County Ordinances regarding public areas to Inshore at least thirty (30) days prior to August 20, 2005.

7. The license may be revoked at any time if there is non-compliance with this Agreement.

8. A deposit of \$100.00 shall be paid to the Clerk's Office, 76347 Veterans Way, Yulee, FL 32097, and shall be refundable within thirty (30) working days following the review of the Parks and Recreation Department that the terms of this License Agreement have been met.

9. The County Administrator shall hear any dispute

as to the return of the deposit.

3. Inshore shall provide the County's Parks and Recreation Department, 45195 Musselwhite Road, Callahan, FL 32011, at least ten (10) days prior to September 16, 2005, with a copy of its liability insurance indicating Nassau County as an additional insured for a minimum of \$1 million.

4. Inshore shall insure that all participants are informed of possible underwater hazards that may cause damage to vessels at low tide at the boat ramp. Inshore shall also advise participants that the use of the boat ramp is "at their own risk", and each participant shall sign a Hold Harmless Agreement that acknowledges that they are participating "at their own risk".

5. The area shall be left in the same condition of cleanliness as it is found and all trash must be placed in the trash containers. Any litter and debris pick-up shall be the responsibility of Inshore during the time of the tournament.

6. The Parks and Recreation Department shall provide all of the existing County Ordinances regarding public areas to Inshore at least thirty (30) days prior to September 16, 2005. Inshore shall be responsible for advising all participants of the requirement set forth in said Ordinances.

7. Each participant shall be advised by <del>Insure</del> that alcoholic beverages are not allow in the Park or boat ramp.

8. The license may be revoked at any time if there is non-compliance with this Agreement as determined by the County Administrator.

9. A deposit of \$100.00 shall be paid to the Clerk's Office, 76347 Veterans Way, Yulee, FL 32097, and shall be refundable within thirty (30) working days following the review of the Parks and Recreation Department that the terms of this License Agreement have been met.

10. The County Administrator shall hear any dispute as to the return of the deposit.
