Below in the email stream are the answers to the two questions that you presented to me on Friday (3/17/06) morning after you met with Judge Foster. Also, it is my understanding from the conversation that you and I had on Friday (3/17/06) that Judge Foster will meet with Chief Judge Moran on Wednesday, 3/22/06 to receive Judge Moran's signature on the the Amended 3/13/06 Spending Plan. If the Amended 3/13/06 Spending Plan meets with Judge Moran's approval and he signs off on the plan, then please let me know if you want me to finalize the event and send the paperwork to Donna in Tallahassee.

Hi Eron,

Per your conversation with Bob this morning, please be advised that your understanding of the issues is correct.

The OSCA must receive Nassau County's executed grant-in-aid and process a check prior to June 30, 2006. However, this does not mean that the funds must be expended by Nassau County by this date. If the spending plan submitted by Nassau County is approved at the OSCA, Nassau County can put these funds aside to pool with the anticipated grant-inaid for FY 06-07. As long as FY 05-06 funds are expended in compliance with the spending plan received and approved by the OSCA, these funds can be expended at a later date. In the interim, these funds should be placed in reserve and not used to support another project. This ensures the intent of the funds will remain clear and no audit criticism will be received.

As Bob mentioned, there is no guarantee of FY 06-07 funds being approved by the Legislature and the OSCA has no influence over this decision. There should be no effect on the FY 06-07 grant-in-aid mandate based on the fact that FY 05-06 funds have not been expended. Numerous county recipients in the past have "pooled" grant-in-aid monies to complete a courthouse renovation project.

As for the amended spending plan, once received I will send you e-mail confirmation, if approved.

Please let me know if a formal letter is needed in reference to the above issues. If so, I will have to send that to you next week. Also, please let me know if you need additional information in the interim. You can reach me via e-mail. Thank you!

Hi Donna,

I spoke with Bob Washington of your office this morning, in your absence, regarding two questions that came out of a meeting last Friday on the Courthouse Facilities grant award for FY 05/06. The two questions are as follows:

- 1. In the process of approaching the Board of County Commissioners regarding amending the spending plan for the FY 05/06 award, the County's Building Maintenance Director requested consideration of possible request for a 12-month extension to the June 30, 2006 end date. The first question that I posed to Bob was: Can a 12-month extension be given to the FY 05/06 award? My understanding from my later discussion with Bob is that as long as the funds for the FY 05/06 award are released from the State to Nassau County, then a reasonable amount of time will be allowed for the items included in the spending plan to be accomplished and that any audit of those funds would not come out negative because those funds were not spent and the items in the spending plan not completed by June 30, 2006.
- 2. The second question centers on the FY 06/07 request submitted in the amount of \$1,271,483.98. Will a 12-month extension to the June 30, 2006 end date for FY 05/06 funds have an adverse impact on the FY 06/07 request for grant funds? Again, according to my later conversation with Bob it was explained that as long as the State has dispersed all of the FY 05/06 funds to Nassau County then there would not be an adverse effect on the FY 06/07 request. Certainly as Bob explained there are no assurances that the FY 06/07 request will be funded but we can be sure that an approved extension of time to spend the FY 05/06 funds will not pose a hardship to the FY 06/07 request.

Also, as a follow-up to the conversation that you and I had on Friday, March 10th, the Board of County Commissioners on March 13th approved the amending the FY 05/06 spending plan and according to information from the Nassau County Building Maintenance Director, Judge Foster is expected to meet on Wednesday, 3/22/06 with Judge Moran, Chief Judge for the Fourth Circuit for his signature and approval on this amended spending plan.

I know that you are out of the office until the 27th but Bob thought you might be able to connect and retrieve this email and send me a confirmation on this reply to the questions included above.
