Golder Associates Inc. (Golder) is pleased to provide the Soiid Waste Department and the Nassau Add Lone 1 County Board of County Commissioners (Board) this cost proposal to prepare a Title V Air Construction Permit Application for the West Nassau Landfill in Nassau County, Florida. This permit application is required to be obtained by the landfill prior to the expansion of the landfill gas (LFG) collection system under the facility's Title V Air Permit. The need for these services at this time is the result of a meeting with the Florida Department of Environmental Protection (FDEP) on November 2, 2005. This meeting was held at the request of FDEP and was regarding comments and questions on the Gas Collection and Control System (GCCS) Plan that had been prepared by Golder and submitted to FDEP dated August 31, 2005. At this meeting, FDEP recommended that the Air Construction Permitting process be conducted as soon as possible so that the construction of the system would not be delayed by permitting issues. Because the FDEP has indicated that it will not issue formal comments on the GCCS Plan, but will essentially provide approval of the GCCS Plan by approval of the permit application, this cost proposal is set up as a change order for additional services under the original GCCS Plan cost proposal (Golder project No. 993-3928.58). The following provides a description of the scope of services to be provided, schedule, cost estimate, and terms and conditions. It is anticipated that by this submittal on November 28, 2005 this cost proposal will be put on the agenda for the Board's consideration on December 14, 2005.

SCOPE OF SERVICES

Golder will prepare the Title V Air Construction Permit Application, which includes a FDEP form and a series of attachments, for submittal to and approval by the FDEP. The attachments include (but are not limited to) the following:

SCHEDULE

Golder will begin preparation of the air construction permit application upon receipt of approval of this task order from the Board. Golder anticipates that a draft of the permit application will take approximately 8 weeks to complete. A draft of this document will be submitted to the County for review. Upon receipt of any comments from County staff, the permit application will be completed and submitted to FDEP for review. Any comments received from FDEP will be addressed within the time frame allowed, which is typically 30 to 60 days.

COST ESTIMATE

Golder's cost estimate to complete the work as described in the above scope of services is \$10,915.00. A detailed breakdown of the costs for each task and the labor and expenses

estimated are included in the attached Table 1. We propose to perform this work on a cost reimbursable not-to-exceed basis in accordance with labor and unit rates shown on the attached table. The County will only be billed actual hours and expenses incurred on the project for work within the agreed scope of services. Direct expenses will be marked-up 10 percent for administrative purposes. Photocopies, computer and AutoCAD time will be billed at agreed upon unit rates. Travel and communications costs (except for specific field activities) will not be billed to Nassau County as stated in our August 1998 proposal. The cost estimate will not be exceeded without prior authorization from Nassau County.
