


**INSTRUCTIONS – DEP FORM 62-621.300(5)(b)**  
**NOTICE OF INTENT (NOI) TO USE MULTI-SECTOR GENERIC PERMIT FOR STORMWATER DISCHARGE ASSOCIATED WITH INDUSTRIAL ACTIVITY (MSGP)**

**Who Must File an NOI:**

Federal law at 40 CFR Part 122 prohibits point source discharges of stormwater associated with industrial activity to waters of the United States without a National Pollutant Discharge Elimination System (NPDES) permit. Under the State of Florida's delegated authority to administer the NPDES program, operators that have stormwater discharge associated with industrial activity to surface waters of the State must file for and obtain either coverage under an appropriate generic permit contained in Chapter 62-621, Florida Administrative Code (F.A.C.), or an individual permit issued pursuant to Chapter 62-620, F.A.C.

Mike,

→ As part of the Permit Renewal, the site needs to apply for a NPDES permit for stormwater discharge. The initial step is to submit a Notice of Intent (NOI) to FDEP in Tallahassee. We can complete the form, however, we need two things from the County: 1) a signature from the Responsible Official (see my earlier email); and 2) a check for \$300 (see details below). Now, this is not an emergency, but this should be completed sooner rather than later as we indicated in our RAI responses that the process of applying for a NPDES permit was underway. The question is do we have to wait for a Board meeting to get a signature (and a check?), or can we send a letter to the Chairman saying Golder has completed the form correctly, etc., and have the Chairman sign it? I realize we are probably in the midst of a Chairman change, which probably complicates things (the Responsible Official should not change immediately).

Anyway, if there is something we need to do to get this underway before the first of the year, please send me an email.

Wendy,

In order to apply for the NOI to use MSGP for Storm water Discharge the following items must be completed:

- Develop a SWP3 or in this case update the SWP3. Last update was in September 1999. Must be updated every 5 years or when a change occurs.
- Complete the NOI form
- Submit the NOI with \$300 to NPDES Storm Water Notices Center, MS #2510, FDEP, 2600 Blair Stone Road, Tallahassee, FL 32399-2400



Authorization is usually granted 48 hours after the date the complete NOI is post-marked to the Notices Center. The Notices Center will send an acknowledgement letter after receipt and processing of the complete NOI and fee. The facility must re-apply for coverage every five years (if the construction activity extends beyond a 5-year period) or submit an NOT to terminate coverage.

I have completed the NOI form except for the Responsible Authority and it is saved in the project directory. The remaining items are to update the SWP3 and get a check from the Board of County Commissioners so we can send the application. FDEP will respond with a letter if more information is required. Please let me know if you have any questions.

*tab* Attached is the cost proposal for implementing the PCAP (sampling and preparing PCAR) as required by FDEP. We have assumed that this will be on the Board agenda on January 11, 2005.

*tab* Additionally, in order to complete the requirements for the permit renewal, specifically, the NPDES permitting and review of Specific Conditions, we will likely need to increase the budget for 993-3928.59. We currently (thru 12/30) have approximately \$2,800 remaining and we still need to update the site's SWPPP and prepare the NOI form. Also, we have submitted the last (hopefully) RAI responses, but there will be a draft of the Specific Conditions prepared by FDEP that we will want to review carefully and we made need to negotiate some items. Therefore, if possible, I'd like to get an increase in the budget for this project of \$5,000. If we don't need that much, we will not bill it. Please let me know if you need any additional information to get this increase on the agenda as well.
