- 3. All provisions of the agreement and any attachments thereto in conflict with this Modification shall be and are hereby changed to conform with this Modification, effective as of the date of the execution of this Modification by both parties.
- 4. All provisions not in conflict with this Modification remain in full force and effect, and are to be performed at the level specified in the Agreement.




Thank you for your continued help with the Nassau County CDBG Housing project.

The purpose of this letter is to request an amendment to the Nassau County CDBG budget. As you are award through the Request for Funds #5 on this project, \$107,500.00 remains in activity #13 for Administration. The Board of County Commissioners voted on December 13, 2006 to request that the Department of Community Affairs allow \$100,500.00 to be moved from activity #13 (Administration) to activity #09a (Housing Rehab/Demo/Replacement) for use in housing construction.

As an update to the CDBG project, please be advised of the following:

- 1. The remaining six (6) homeowners have terminated their contracts with Robert Mayhugh and The TR Group.
- 2. The issues regarding Mr. Mayhugh and his company, The TR Group have been referred to the State Attorney's Office for investigation.
- 3. The issues regarding grant administration and Jordan & Associates have been referred to the State Attorney's Office for investigation.
- 4. A new bid process is underway for the remaining six (6) project sites.
- Two projects are new construction and the former home was demolished by Mr. Mayhugh and The TR Group and new construction never began.

- 6. Two projects are new construction to complete, meaning the new homes were started but never completed by the general contractor.
- 7. One home was submitted for rehabilitation.
- 8. The remaining home is a mobile home that was previously submitted for rehabilitation and now, based upon a recent assessment of the home, will have to be demolished and a new home built on the project site.
- 9. The bid opening and contract awards will occur in January 2007.
