AGREEMENT

THIS AGREEMENT made and entered into this 10th day of 2002006, by and between the County of Nassau, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and the Nassau County Volunteer Center, hereinafter referred to as VOLUNTEER CENTER.

WITNESSETH

WHEREAS, it is in the best interest of the citizens of Nassau County that there be a VOLUNTEER CENTER.

WHEREAS, the VOLUNTEER CENTER is the clearinghouse for volunteer recruitment activities in Nassau County.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. For and in consideration of the sum of \$3,000.00, which shall be paid in quarterly installments, during the months of November, February, May and August, the VOLUNTEER CENTER does hereby agree to perform services that will benefit the residents of Nassau County. Said services to include but not be limited to the following:
 - a. Continue the present level of services provided for volunteer recruitment activities in Nassau County and to mobilize people and resources, through the promotion of volunteerism, to deliver creative solutions to community problems.
- 2. The VOLUNTEER CENTER shall make their financial records available to the Clerk of Courts on behalf of the COUNTY for purposes of an audit, if requested by the COUNTY or the Clerk. The COUNTY shall require an audit of previous fiscal year's financial records to be performed by an independent accounting firm. The audit report must be presented to the COUNTY and accepted by the Clerk of Courts before the May distribution is made.
- 3. All facilities, programs, and services shall be compliant with the Florida Accessibility Code and

the federal Americans with Disabilities Act. Failure to provide facilities, programs and services that are compliant with both the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA) shall be considered a breach of the contract.
