## MEMORANDUM OF UNDERSTANDING BY AND BETWEEN NASSAU COUNTY AND THE CITY OF FERNANDINA BEACH, FLORIDA AND THE NASSAU COUNTY SHERIFF'S OFFICE REGARDING PUBLIC SAFETY PROTECTION OF THE MOORING FIELDS AT THE CITY MARINA

WHEREAS, the parties to this Memorandum of Understanding are Nassau County, Florida, hereinafter "County" and the City of Fernandina Beach, Florida, hereinafter "City; and the Nassau County Sheriff's Office

WHEREAS, the City owns and operates the City Marina for the use of the boating public, both City and County residents and non-residents; and

WHEREAS, as part of the continued development of the Marina, the City has developed plans for the installation a Mooring Field; and

WHEREAS, the Mooring Field is adjacent to the Marina outside of the corporate limits of the City on sovereign submerged land, within the jurisdiction of the County. The Mooring Field will require a sovereign submerged land lease with the State of Florida; and

WHEREAS, The Nassau County Sheriff's Office has responsibility and authority to patrol County waters for compliance with State laws and statutes pursuant to 253.05 Florida Statutes

WHEREAS, the State of Florida is requesting as a part of the lease, that the area of the Marina, Mooring Field, and the waters of Kingsley Creek, the Amelia River, and their tributaries to a westerly limit at longitude -81° 28' 57" from north of State Road 200 to the State Line and east to the Atlantic Ocean be patrolled and protected. The County Sheriffs Office agrees to protect and patrol these areas through existing County Sheriffs Office Programs.

WHEREAS, currently the City and County mutually provide Law Enforcement through participation by the Nassau County Sheriff's Office as well as Fire and EMS to residents of the City and County through mutual aid agreements; and

NOW THEREFORE, THE CITY, THE COUNTY, and the COUNTY SHERIFF'S OFFICE AGREE AS FOLLOWS:

1. Pursuant to Florida Statute 253.05, the City, County and County Sheriff's Office agree to jointly cooperate in providing law enforcement, the prevention of unauthorized mooring, fire and EMS duties relating to the Mooring Fields and the waters of Kingsley Creek, the Amelia River, and their tributaries as specified above.

- 2. The City shall pass an Ordinance which adopts a Marina Management Plan. That Ordinance and Management Plan shall be attached and incorporated herein by amendment.
- 3. The City, County and County Sheriff's Office may adopt such subsequent agreements, of whatever type, which may be required to fulfill the law enforcement, fire and EMS duties of the Mooring Fields.


